- **Project Initiation.** Working closely with project managers we agree the commissioning plan and establish key success factors and deliverables such as project timescales and budgets.
 - **Sourcing Strategy Support.** Through consultation with project managers, clinicians and medical engineering we agree the appropriate purchasing methodology for the various types of equipment. Taking account of the value, complexity and lead times we advise on the most appropriate commercial procurement strategy.
 - **Budgetary Control Mechanisms.** We provide an estimated budget, establish funding mechanisms, develop final cost schedules and determine priority purchases. Budget reports are regularly provided showing commitment to date thus enabling accurate profiling of expenditure.
 - **Equipment Consolidation.** Schedules for all rooms within the scheme are produced which classify equipment groups, costs and quantities, consolidate equipment requirements and forecast equipment costs. The result is the

- production of an equipment buying schedule which can be procured locally or by utilising the procurement expertise of the NHS SBS Capital Team.
 - **Equipment Transfer.** Equipment transfer criteria are proposed, agreed and an audit undertaken against this criteria. Overall capital costs are reduced by identifying equipment which can be reused. Costs associated with the equipment to transfer are assimilated into the overall budget schedule.
 - **Source Equipment.** We prepare the necessary documentation to benchmark costs, produce loaded drawings, manage the procurement process and support evaluation trials if required.
 - **Evaluate Equipment.** Through the assessment of whole life costs and maintenance implications we determine the preferred supplier(s) providing robust recommendation reports that demonstrate how value for money has been achieved.
 - **Order Equipment.** With your approval and in adherence to your organisation's Standing Financial Instructions and Project Commissioning Plans we place equipment orders using your systems which can be accessed on site or remotely as appropriate.
 - **Equipment Receipt & Distribution.** We receive, distribute and commission new equipment within the facility thereby ensuring all equipment is delivered on time, to the correct place and is ready for operation. If staff training in the use of equipment is required we are ideally placed to organise this for you.
 - **Removals.** We tender for and manage removal contracts and the transfer of specialist equipment.
 - **Project Completion.** Upon project completion we provide a comprehensive handover document that includes an asset register, warranty details, service and maintenance agreements and project benefit reporting.

Delivering Value

The Capital team utilises NHS SBS Framework Agreements for the vast majority of its capital procurements, including major radiology equipment, medical equipment and furniture. Where possible, we aggregate demand for products across projects, performing mini competitions which lead to fast OJEU-compliant procurement routes and further reductions in costs.

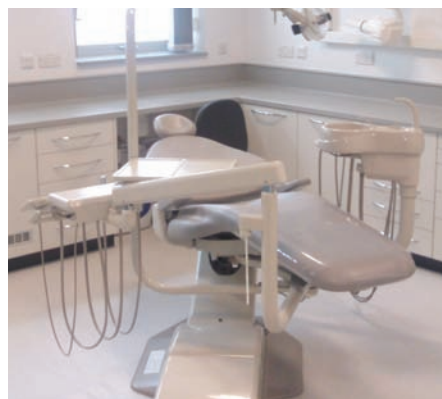


Evidence of our Success

Glossop Primary Care Centre – June 2010.

NHS SBS worked with Glossop Primary Care Centre to provide appropriate furniture, clinical, medical & IT equipment for a wide range of clinical services in its two-storey, 13,000m² Primary Care Centre.

The NHS SBS Capital Team worked closely with the Local Improvement Finance Trust project manager to provide a complete capital procurement service that included gaining agreement on colour choices and specification of equipment with individual services alongside maintaining an overall high quality building standard suitable for all clients. All furniture and equipment was procured on time within budget and in accordance with OJEU legislation. The logistics manager from the NHS SBS Capital Team managed the receipt, distribution and commissioning of all new equipment and was even responsible for managing access to the new building during the commissioning stage.



Lancashire Women and New Born Centre – November 2010

NHS SBS Capital Services was responsible for the on-time procurement and delivery of all furniture and equipment for a new standalone unit at Burnley General Hospital. The project involved moving services from Royal Blackburn Hospital to Burnley General Hospital and was delivered within an extremely challenging budget.
