NET ZERO CARBON REDUCTION PLAN

Commitment to achieving Net Zero

- NHS SBS acknowledges the Climate Emergency and journey to Net Zero.
- NHS SBS will be Net Zero by 2040.
- We are committed to accelerating and supporting the NHS in its ambition to become the world's first Net Zero health service.
- NHS SBS embraces the collective and urgent responsibility to address the
 causes of climate change and enhance the resilience of the business, the
 NHS and its supply chain to withstand climate change impacts now and in
 the future.
- We will drive to accurately measure 100% of our carbon emissions using the best available data.

Defining Net Zero and Baseline

NHS SBS, together with Sopra Steria are proud to be considered early adopters of climate standards since 2017, where we aligned our science-based targets well below 2°C which were validated by the Science Based Targets initiative (SBTi). Later in 2019 these targets were updated to be 1.5°C aligned. In 2020, we adopted the UN Climate Neutral Now definition of Net Zero. This definition is defined as "the state where a balance between anthropogenic greenhouse gas (GHG) emissions and removals is achieved". Under this definition, Net Zero could be achieved with a combination of carbon offsets and direct reduction of emissions.

As the effects of offsetting continue to evolve, as an organisation we are moving towards a more ambitious Net Zero target with a greater focus on reduction and less on sequestration through offsetting and carbon credits.

In 2022 Sopra Steria Group together with NHS SBS committed to the SBTi Net-Zero Standard and adopting its definition of Net Zero. This will enable NHS SBS to strive towards achieving a 90% reduction in absolute emissions from a baseline measurement by no later than 2040. The SBTi have indicated that revised targets aligned with the SBTi Net-Zero Standard criteria, submitted by Sopra Steria Group in November 2022, will be validated around July 2023.

As stipulated by SBTi, the baseline period can be no longer than 3 years prior to commitments and will therefore change from 2017 to a later year. The emission data we have used on this Carbon Reduction Plan reflects our current baseline year of 2017. The plan will be updated to show the new baseline year once is it accepted by SBTi in later 2023.

NHS SBS intends to achieve Net Zero emissions by 2040 at the latest, utilising a phased approach of both long- and short-term targets.



Completed Carbon Reduction Projects

The following environmental management measures and projects have been completed or implemented since the 2017 baseline.

- NHS SBS maintains and continually improves its Environmental Management System, which is externally certified to the ISO 14001:2015 standard.
- In 2019, NHS SBS had raised the proportion of electricity consumed from renewable sources to 100%, reducing Scope 2 emissions to zero on a market basis.
- Sopra Steria signed an agreement to upgrade its company car scheme, which will focus entirely on environmentally friendly and tax-efficient Battery Electric Vehicles (BEVs) and Plug-in Hybrid Electric Vehicles (PHEVs). The scheme was launched for NHS SBS employees in 2022 and also offer support to employees with arranging discounted home charging points.
- 100% of waste, from collections managed directly by NHS SBS, is diverted away from landfill. Since 2019, NHS SBS has collaborated with its catering contractor in replacing plastic packaging of food and drinks sold at on-site

canteens with packaging made from plant-based material. This has helped to eliminate over 40,979 items of single-use plastics from NHS SBS's waste.

- By collaborating with its office stationery supplier and its partner, NHS SBS
 has been able to reduce the environmental impact of the paper that it uses
 by purchasing closed-loop paper. Using closed-loop papers means that
 NHS SBS's used paper is recycled and remanufactured back into a paper
 product. Therefore, we adopt the principles of the circular economy. No
 deforestation takes place to provide the fibre in the paper that NHS SBS
 subsequently purchases, which requires:
 - o 83% less water;
 - o 72% less energy; and
 - o 53% less CO emissions.
 - ... to manufacture than fresh fibre paper
- NHS SBS is relocated to a new office in Leeds during 2022, achieving a Silver SKA certification demonstrating many positive environmental outcomes embedded in the design and fit out of the office.

Carbon Removal Initiatives

In 2020, Sopra Steria and NHS SBS migrated its offsets for carbon neutral certification to a new partner accredited by the United Nations Climate Neutral Now programme. This partner invests in projects that remove the primary GHG carbon dioxide from the atmosphere, particularly afforestation projects in Uruguay that create new land for trees that absorb carbon dioxide from the atmosphere, and that do not simply replace trees in deforested areas.

Future Initiatives

The Carbon Reduction Plan, as part of our SBTi Net Zero 2040 target is a key component of our wider Environmental Sustainability programme. This programme integrates our ISO14001-certified Environmental Management System, efficient resource consumption, renewable energy, circular economy, sustainable supply chain and support for our clients with solutions and services in their transition to a Net Zero economy.

 During 2023 NHS will be extending the scope of its ISO 14001 certification to include the Southampton office.

 Sopra Steria is due to have the SBTi validate its revised targets in-line with its SBTi Net Zero Standard in July 2023.

Declaration and Sign-off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and uses the appropriate Government emission conversion

factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Carporate Value Chain (Scope 3) Standard³

and the Corporate Value Chain (Scope 3) Standard³.

This Carbon Reduction Plan, for the Financial Year ending on 31st December 2022, has been reviewed and signed off by the board of directors (or equivalent
