Background

Within the UK suicide is responsible for the death of thousands of lives per year, with nearly 6000 occurring in 2017.

This equates to a death by suicide every 2 hours, with many more failed attempts.

Suicide is the leading cause of death among young people aged 20-34 years in the UK and it is considerably higher in men.

Only 27% of people who died by suicide between 2005 and 2015 had been in contact with mental health services in the year before they died.

Public sector staff play an important part in helping to prevent suicide; improving their education and awareness is vital to save lives.

The Five Year Forward View for Mental Health set out clear recommendations on suicide prevention and reduction, and made a commitment to reduce suicides by 10% nationally by 2020/21 and a zero suicide ambition for mental health inpatients in January 2018.

When does the framework start?

3rd July 2018- 2nd July 2022 extended until the 2nd of January
